Well, another season done and dusted! With our Meteorite Gift Day tomorrow it concludes another pretty impressive year for us.

This season was a season of incredible achievements and firsts for our club. The most obvious is the record number of athletes this season of 496! With cross country still to come, we will undoubtedly cross the 500-membership milestone. Huge shout out to Bron and Katrina, the registrations team all those that help out on the deck dealing with all the enquires and trying to make the process and experience as smooth as possible. It isn't easy up there but you guys make it look smooth.



Big thank you to Dave as Sponsorships and Grants Officer this year. The amount of planning done in the off season last year, devising new packages and riding the wave of having been awarded the most active club on socials last year as well as being able to print sponsors logos on our uniforms or the 3 year sponsorship packages are all new initiatives which resulted in building stronger partnerships and we look forward to partnering with our current and any new sponsors even more closely in the future.

From a Grants perspective, we were also successful and enabled us to put ten committee members through first aid training as well as the acquisition of new starting devices for the club.

Coming back for a full season, with all the trimmings after the Covid years with record member numbers isn't easy but the clubs' results speak for themselves - whether it be on the track, or behind the scenes so much work has gone into ensuring the athletes had the best experience this season as well as putting in place initiatives for the next season.

How good is it seeing record number of PB's or the huge number of fantastic results at Region or State? How good is it seeing Cranbourne parents screaming on the sidelines showing passion not only for their kids but anyone wearing the Blue, Yellow and White.

On that note I would like to thank both Dean and Adam for all their hard work, both on the coaching side of things as well as ensuring the athletes are always a priority considered in every aspect. The passion both these guys have is amazing and our club is better off for having them.

We hosted the Region Track and Field this year for the first time in a number of years and the feedback from GCR and Lavic was fantastic.

Lots of work went into it ensuring there was a carnival type atmosphere. Shout out to Annette, Megan and Michelle and all the helpers – the canteen and BBQ ran smoothly, and it showed everyone we have the ability to host such a large event.

Our financial position whilst strong has been of the back of some really smart decisions. We invest heavily back into the club and sometimes it isn't what we buy, rather what we say no to. More members mean more revenue, but it also means more money spent on uniforms and trophies and so on.

Huge thank you to Megan for ensuring our process are set up correctly so auditing and stock control is easier. Megan will take you through where the money has been spent in more detail as



well as what's still to come that we can invest back into the club during the cross-country season.

For those that aren't aware yet, I would like to mention for those that aren't aware yet, we have been nominated by Lavic for the inaugural Little Athletics Australia Metro Centre of the Year. One centre gets nominated per State so watch this space. In addition, we are also Number 1 in the country for engaging content on social media. We have so much good stuff happening here all the time, so huge thank you to Andy who keeps making us look good! Keep those likes and comments coming!

We are definitely stronger together! It takes an enormous number of dedicated people to run the season and on that note, I would like to acknowledge and personally thank all of you.

To those new to Cranbourne this season, thank you, your help is amazing, and to those who have been around the track a few years and know the drill - you are really appreciated. The club wouldn't be in this position without the week in week out help from you guys!

From ensuring every Saturday is set up, to the computers and gates working, to the canteen and uniform shop, or to the coaching and general help, this club gets better and better each year because of your loyalty and dedication. Thank you.

This season was all about getting back to normal. We did that and blew it out the water.

Next season is our opportunity to bring more good stuff and continue the hard work put in over the past few seasons.

## Treasurer's Report - Megan Crowley

This year our accounts were again audited by S&H Accountants in Cranbourne. The Club's Financial year is from January to December, and this is our first full financial year, without any COVID Impacts. The club's profit for the financial year per the attached financials is \$52,198.

This result has been directly impacted by the large increase in registrations for the 2022 season (well done to the Registration Team!) and the amazing job of sponsorships and grants. A huge thank you to David Kohl for the amazing job he has done this season. David and Bronwyn will provide more information relating to these sections in their reports.

The increase in registration numbers has also increased many other areas of the club, including uniform and canteen sales. Fundraising has also increased this year, with the fundraising team running several successful raffles throughout the year.

Our day-to-day operating expenses were lower this year due to issues with obtaining regular first aide from St Johns (which is one of our largest expenses). The club tried to



combat this challenge by investing in providing training to our club officials (of \$1,200) to enable us to still provide care to our athletes when needed.

Rates and Utilities are also still being financed by Melbourne City for the most part, with our electricity and gas fees negotiated at a fixed rate per quarter. This will only continue whilst Melbourne City are occupying our club rooms.

Uniforms expenses also increased during the year with multiple orders having to be placed in order to keep up with the demand of our members. This proved challenging at times, as we are working with external entities and processing delays. A big thank you to Vicky Delgos for all of her assistance in running the uniform shop this year.

Our other major expense for the season is investment back into the club. Sponsorship and Grant monies are utilised to purchase new equipment for our athletes and to ensure that the club can function as well as it possibly can.

Some of our major purchases/upgrades totalling over \$10,000 include:

- 2 x Electronic Starting Devices
- 2 x First Aide Kits
- Multiclass Throw Chair
- Upgrades to general equipment (Cones,
- New Tables for Jump Pits
- 2 x New Computers (secretary & registrar)
- New Mobile Phone for Club

In the 2023 season we will be further looking to upgrade equipment where we can. Some of the items on our wish list for 2023 include:

- More specialised equipment for our Multiclass Athletes
- New High Jump Mat Trolley
- New Trailor for the Club to use at region & state events.
- New signage for around the track (banners & signs)
- New Blocks for our athletes.
- Additional Uniform Secured Storage.
- Specialist Coaching
- Investment back into our coaches to expand their knowledge to assist our athletes.

Finally, we also have many expenses post financial end, which obviously impacts on the above figures. This will include Medals, Printing, Trophies and Presentation Day expenses just to list a few. These expenses are also expected to increase this year as a result of the increased athlete numbers also.

Thank you to all the executive committee and the club for entrusting me with this role. I have enjoyed working with all executive and committee members and financial team members including Vicky (uniforms), Michelle and Bernie (Canteen), Debbie (fundraising) and Dion (Gates). Thank you for the roles you play in enhancing our club.

Finally, also a big thank you also to Bernie and Terry who were our Canteen Manager and assistance for this year. They have been a huge help over the past few seasons and are "retiring" from the role to get some much-earned rest on a Saturday morning. I look forward to the club continuing from strength to strength in 2023.



## Head Coach Report - Adam Bocor

This was my first season as Head Coach and our coaching team hit the ground running. We had ambitions of offering as many coaching opportunities as possible, ranging across all levels of skill and ability.

We delivered on this, with an amazing group of coaches who committed to the plan, providing the athletes with coaching across all events. As coaches we can only do so much, and it is the athletes who put in the hard work and achieved great success. I am so proud of these kids.

We put the hard work in with relays and saw huge progressions to state with multiple state medallist teams. We also saw great success at Region Track & Field. The outstanding performances by athletes at region resulted in a significant amount of state progressions and medallists.

At a centre level the amount of PBs achieved was outstanding, with so many centre records being broken. Overall, the results were more amazing than I could have ever expected.

Going forward we have a few new additions to the coaching crew, who I am really looking forward to working with. The plan will be to continue the trend of offering as many coaching opportunities as we can to the athletes.

We have some new ideas to extend some of our higher achieving athletes with a new initiative in the works. We plan to focus on technique and fitness with all of our athletes, hoping to continue supporting them to reach for the stars and achieve their goals.

## Notes to the Financial Statements

## Cranbourne Little Athletics Centre For the year ended 31 December 2022

#### 1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act of Consumer Affairs Victoria under the Associations Incorporation Reform Act 2012. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

#### Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised (if any) over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

#### **Impairment of Assets**

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

#### Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result ofpast events, for which it is probable that an outflow of economic benefits will result and that outflowcan be reliably measured. Provisions are measured at the best estimate of the amounts required tosettle the obligation at the end of the reporting period.

#### **Accounts Receivable and Other Debtors**

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### **Revenue and Other Income**

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.



Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

**Revenue Recognition** 

Revenueis recognised when the centre is legally entitled to the income and the amount can be quantified with reasonable accuracy. Revenues are recognised as GST free amounts received, as club is currently not required to be registered for GST purposes.

Revenue from Canteen: Sales Revenue from canteen sales is recognised when canteen food items and BBQ food items is sold and collected.

Revenue from gates: Revenue from gate hire is recognised when received from hiring Primary and Secondary Schoolbodies.

Revenue from Member Registrations: Revenue from registrations is recognised when received from LA Vic.

Revenue from Fundraising: Revenue received from fundraising activities such as raffles, sausage sizzles & trivia night are recognised as revenue when received

Revenue from Uniform Sales: Revenue from Uniform sales is recognised when uniform is sold and collected is accounted for on aaccruals basis and has been classified underheadings that aggregate all costsrelated to that category. Canteen purchases relate to items purchased for resale at the club's canteen operated on competition day/night.

Equipment purchases relate to equipment required to run and sustain the Little Athletics program and events it participates in. First Aid Services relate to the provision of first aid on program and meet days.

Fund raising expenses relate to items purchased required for the operation of fund raising activities. Uniform Purchases relate to purchases of said uniform stock for re-sale throughout the season. Where costs cannot be directly attributed to acategory they have been shown as other expenses.

#### **Financial Assets**

Investments in financial assets are initially recognised at cost, which includes transaction costs, and are subsequently measured at fair value, which is equivalent to their market bid price at the end of the reporting period. Movements in fair value are recognised through an equity reserve.

Fixed Assets: Asset purchases are written off in full when they are purchased, however are reflected in the balance sheet as an Asset of the club. The asset is then written off fully and claimed as an expense in the year of purchase. As per club financial reports supplied.

Stock on Hand: Stock on Hand comprises of Canteen Stock and Uniforms. These are recorded at cost and a stock take is undertaken at the beginning and end of each season.

#### **Accounts Payable and Other Payables**

Accounts Receivable Comprise of amounts due by families on registration fee payment plans for the Cranbourne Little Athletics Centre, and are recognised and carried based on the originalinvoice. Normal Terms of settlement vary, however must be paid by the end of thesummer little athletics seasonfor children to be eligible for end of season awards, andfor parents to have voting rights at the AGM.In addition, receivables also includes amounts due from schools for paymentof gate hire for school athletics carnivals, and are recognised and carried based on the original invoice. Terms of settlement are 90 days.Bad Debts are written off once identified.
